MEMORANDUM OF UNDERSTANDING

This Memorandum of Understanding (MoU) is executed on this 9th August 2024 at Karamsad between Indubhai Patel College of Pharmacy & Research Centre, Dharmaj managed by Sanskruti Sanraksha Charitable Trust; having its registered office at Dharmaj, through its Principal hereinafter referred to as IPCPRC which includes its heirs, assigners, executors, administrators etc.

AND

Bhaikaka University incorporated as private university under the Gujarat Private Universities Act, 2009 having its registered office at the Bhaikaka University, Shree Krishna Hospital Campus, Gokal Nagar, Karamsad 388 325, Dist: Anand, Gujarat, representing through its Provost, Bhaikaka University hereinafter referred to as BU.

IPCPRC is one of the leading institutes in the field of Phamaceutical Education, providing top-notch pharmacist to serve society who have imbedded virture of "वसुधैवकुटुम्बकम" (All world is a Family). Institute not only provides technical knowledge but also nourishes all students with skills to withstand all kinds of situation in life. Indubhai Patel College of Pharmacy and Research Centre (Formerly known as Dharmaj Degree Pharmacy College) started in the year 2006 with a vision to provide education in the vicinity of Charutar region. The institute is approved by AICTE, PCI and affiliated to Gujarat Technological University, Ahmedabad.

BU is managing institutions in the field of Health Profession Education and Research like Pramukhswami Medical College (PSMC), H M Patel Institute of Post graduate studies, K M Patel Institute of Physiotherapy, G H Patel School of Nursing, G H Patel College of Nursing, Smt. - (iv) Seek finance of joint activities from sources available to them; however, the financial aspects of each activity will be addressed separately and an explicit documentation will be done for that purpose.
- (v) All intellectual property rights and their costs will be shared jointly through mutual discussions. All (raw) data resulting from joint research projects, between the Parties which constitute the basis for joint publications must be available for storage in the repository of each Party.
- (vi) Students of IPCPRC will not be allowed to deal with patients independently at Shree Krishna Hospital.
- (vii) This MoU may be terminated by either party with advance written notice of 30 days or by mutual understanding between the two parties.
- (viii) Any differing viewpoints and interpretations of this MoU shall be settled by mutual consultation or negotiation.

This agreement shall remain in force till the completion of the said project.
