#### **MEMORANDUM OF UNDERSTANDING [MOU]**

#### **About Sardar Patel Education Campus:**

Sardar Patel Education Campus [SPEC] is a student centric, multidisciplinary, research and holistic development oriented not for profit campus with a view to promote welfare. Within a short span of time, since 2007 till date, it has emerged as a campus known for teaching-learning-activities across the state of Gujarat. The campus, spread across the sprawling lush green environment and a bit away from noise and pollution of city, has number of institutes, named after Iron man of India – Shri Sardar Vallabhbhai Patel, including SPCP, SPCE-ENGG, B.Voc. [AC & Refrigeration, Software Development], SPCAM - MBA, B.Voc. [BFSI], SPCAM [BBA, BCA, BBA/ISM], SPCC [B. Com, M. Com], SPCE [B.Ed.] and SPIAS [B.Sc., M.Sc.(IT)]. All technically professional courses are affiliated to Gujarat Technological University and other courses are affiliated to Sardar Patel University.

#### **About Bhaikaka University:**

Nearly five decades ago, Charutar Arogya Mandal was established as a venture of hope. The Mandal was founded by the late Dr. H. M. Patel, former Union Home and Finance Minister, whose dream was to offer comprehensive, compassionate health care to everyone and anyone who needed it. The Charutar Arogya Mandal was formed in 1972 as a non-profit Trust and a Society; to work in the area of health care and education.

Bhaikaka University is a Private University incorporated under the Gujarat Private Universities Act, 2009 and the Charutar Arogya Mandal is a Sponsoring Body of this University.

In accordance with a mutual desire to promote and develop activities between two organizations, namely Sardar Patel Education Campus, Bakrol and Bhaikaka University, Karamsad, we agree to the following statements of intent for education and research cooperation. The cooperation in specific areas may be designed by mutual consent and incorporated into specific additional agreements upon signature by the institutions' appropriate authorities.

Both the parties agree to the following general areas of interest and cooperation:

- A. Work with mutual collaboration in the areas of Research & Development, Education & Training, Healthcare and Facility Utilization.
- B. Organization of professional academic programmes.
- C. Joint promotion of each other's expertise and capabilities.
- D. Facilitate effective utilization of the intellectual capabilities & collaboration for Krupa Arogya Suraksha Scheme [With reference of letter KAS/39, dated 08/06/2022; Inward No. 6624].

The students & stakeholders of both the parties will strictly abide by the rules of respective party and any kind of violation thereof will lead to denying the facilities available. Any damage caused by any student to the property or clinical facility will be compensated by concerned party.

Both the parties shall not make any endeavours to have covetous gain from this agreement.

All intellectual property rights and their costs will be decided with mutual discussions. All (raw) data resulting from joint research projects, between the parties which constitute the basis for joint publications must be available for storage in the repository of each party.





Any differing viewpoints and interpretations of this MoU shall be settled by mutual consultation or negotiation.

Both the parties agree that all financial arrangements necessary to implement this MoU or any subsequent agreement must be negotiated according to the regulation of each institution and depends on the availability of funds. Both the parties recognize that:

> This MoU establishes a foundation of mutual understanding & interest and does not itself entail any financial obligations for either institution.

No financial commitment or liability from any party will be assumed unless a formal approval/acceptance to that effect has been accorded through signed documents by both the parties.

This MoU will be in effect from the date of its signing and shall be valid for the period of three years from that date, unless terminated earlier upon 30 days' written notice by either party.

This MoU may be revoked or modified by mutual agreement between the parties and may be extended beyond its initial three years' term by mutual agreement.

This MOU is being signed on <u>O2</u> <u>SePtembel</u>2022 and will stand effective from the same date.
