



MEMORANDUM OF UNDERSTANDING

This Memorandum of Understanding (MoU) is executed on this 27th June 2022 at Karamsad between Bhaikaka University incorporated as private university under the Gujarat Private Universities Act, 2009 having its registered office at the Bhaikaka University, Shree Krishna Hospital Campus, Gokal Nagar, Karamsad 388 325, Dist: Anand, Gujarat, representing through its Registrar, Bhaikaka University hereinafter referred to as **BU**

AND

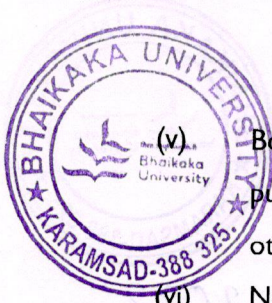
J. V. Patel GIA ITI, Karamsad having its registered office at Karamsad, through its Principal hereinafter referred to as **J. V. Patel ITI** which includes its heirs, assigners, executors, administrators etc.

BU is managing institutions in the field of Health Profession Education and Research like Pramukhswami Medical College (PSMC), H M Patel Institute of Post graduate studies, K M Patel Institute of Physiotherapy, G H Patel School of Nursing, G H Patel College of Nursing, Smt. L P Patel Institute of Medical Laboratory Technology and CAM Institute of Allied Health Science & Technology along with Shree Krishna Hospital (SKH) as a teaching hospital along with Bhanubhai & Madhuben Patel Cardiac Centre, M S Patel Cancer Centre and Dinesh J Patel Bone Marrow Transplant Centre in the same campus.

J. V. Patel ITI runs professional industrial training programmes under an advisory centre, National Council of Vocational Training.

Now this Memorandum of Understanding is executed incorporating the following terms and conditions:

- (i) The primary objective of this MoU is to create means for collaborative efforts between J. V. Patel ITI & BU and to share knowledge in the area of training and research.
- (ii) The Parties agree that this MoU will provide the foundation and framework for projects, developed by training and research units from the two Institutions, with separate written MoU if needed.
- (iii) This MOU shall be in full force for a period of 3 years with effect from the date written above. This MoU may be terminated by either party with advance written notice of 30 days or by mutual understanding between the two parties. However, it is understood that upon the termination of this MoU, the ongoing project/research work, if any, may continue till its completion.
- (iv) Both parties agree to maintain confidentiality and privacy safeguards. Both parties also agree that any information which are confidential in nature will not be released to any third party/person.




Both the parties will also have the privilege to use study data/material/information for publication and academic purpose, subject to prior information and after taking consent from other party.


