MEMORANDUM OF UNDERSTANDING

This memorandum of understanding is made on 11th day of August 2017, between Charutar Arogya Mandal, (managing the Shree Krishna Hospital Karamsad and Pramukhswami Medical College, affiliated to SP University, V Vidyanagar,) a charitable Trust registered under the Bombay Public Trust Act 1950, having its office at Gokal Nagar, Karamsad Gujarat 388325, (herein referred as CAM, which expression shall, unless repugnant to the context or meaning thereof, include its successors and permitted assigns), represented by its Chief Executive Officer

and

Anand Pharmacy College, Opp. Town Hall, Anand, Gujarat-388 001 run by Shri Ramkrishna Seva Mandal, affiliated to Gujarat Technological University, Chandkheda, Ahmedabad, Gujarat, (herein referred as APC, which expression shall, unless repugnant to the context or meaning thereof, include its successors and permitted assigns) represented by its Principal.

The parties hitherto agree as follows:

- CAM declares that it manages a 720 bedded hospital named Shree Krishna Hospital, with a minimum of 120 beds for General Medicine Department.
- 2. CAM agrees to make available to APC the minimum space necessary of 1200 square feet in its premises to establish Pharmacy Practice department for the conduct of Pharm.D programs.
- CAM agrees to provide preceptors required to train the Pharm.D students.
- 4. CAM agrees that, it will not enter into similar agreement with any other Pharmacy institution /s or department/s offering or intend to offer Pharm.D programs, till this agreement is in effect.
- CAM agrees that the prospective students will be allowed to undergo training in the following specialty departments
 - o Medicine
 - o Surgery
 - o Pediatrics
 - Gynecology and Obstetrics
 - o Orthopedics
- 6. APC will provide the academic staff and necessary infrastructure for Pharm.D course as per the PCI norms and takes the overall responsibility for smooth conduct of the programs.
- 7. This agreement shall remain in effect for a period of ten years from the time of its endorsement by both the parties.

The officials representing CAM and APC are signing this MOU to achieve the beneficial objectives of Pharm.D programs.
