



MEMORANDUM OF UNDERSTANDING

For providing specialist Doctor's consultation for camps

Agreement entered into this 30 day of July, 2024

This Memorandum of Understanding (MoU) is entered on this 30 day of July, 2024 at Anand

BETWEEN

The Chief District Health Officer, District Panchayat, having office at Sardar Vallabhbhai Patel Bhavan Building, 3rd Floor, Health Branch, Borsad Chokdi- Anand-388001

AND

The Bhaikaka University, a private university incorporated under the Gujarat Private University Act, 2009 having its office at Gokalnagar, Karamsad hereinafter referred as **BU**. The **BU** is imparting health care services, medical education and research through its constituent units, Shree Krishna Hospital and Pramukhswami Medical Gollege and others.

The District Panchayat Anand has launched a health care project under the name and title of Varisth Suvarnyug Program (VSP) for the benefit of elder (60+) population of Anand District. Under the said programme the Chief District Health Officer (CDHO) will tie up with the leading Public Health Institute (PHI) located at Anand district for health care consultation for the benefit of the elderly people. Under this programme the CDHO will make an arrangement for health check-up camps at the various parts of the Anand district with the help of the PHI.

The CDHO has primarily selected 8 PHI for tie up with the Anand District Panchayat (ADP) for providing consultation services of their consultants at the camp organised by the CDHO. The BU is one of the PHI selected by the ADP therefore the the ADP has proposed the BU to enter into this deed.

The terms and conditions of this MoU will be as under:

- 1. The CDHO will inform to the BU atleast 15 days in advance about the camp, its place, time and need of consultants.
- 2. The CDHO will prepare the health indicators check list and it will be shared to the BU well in advance.

- 3. Upon the receiving the requirement as stated above, the BU will ensure the availability of the consultants timely.
- 4. The CDHO will ensure that the camp duration of such camps will not be more than three hours.
- 5. The CDHO will be responsible for all the arrangement related to organizing the camps which includes but not limited to sitting arrangement, drinking water/ clinical and other material/para medical staff, to & fro vehicle arrangement for consultants.
- 6. The period of this MoU will be one year effective from 1st July, 2023. At the end of this MoU it can be extended further on mutual agreement by both parties.
- 7. The CDHO or ADP will not make any payment to the BU for providing consultation services for camps.
- 8. The CDHO is authorised to monitor of this programme under the guidance of the ADP.
- 9. Any Amendment to this Agreement shall be valid and binding on the Parties only if it is made in writing and signed by duly authorized representatives of each Party.
- 10. The Contribution of services provided by the BU to ADP under this MoU does not imply any further commitment to this Project or any other projects, other than as expressly provided in this MoU.
- 11. Any dispute or difference between the parties arising out of or in connection with this MoU including the validity thereof shall at first instance be resolved amicably through negotiations or discussions between the parties.
- 12. If the dispute remains unresolved then the same shall be taken up by the Heads of the both parties or their duly authorized representatives who shall strive to resolve the dispute amicably
- 13. Any amendment, notice, or other communication under this Agreement shall be sent by personal delivery or courier or email/ facsimile or by registered mail to parties at their respective addresses set forth below:
