## MEMORANDUM OF UNDERSTANDING

This first Memorandum of Understanding (**MoU**) was executed from 01/01/2022 to 31/12/2023 at Karamsad between **Charotar University of Science and Technology**, Changa established under Gujarat Act No.8 of 2009; having its registered office at Changa, through its Registrar hereinafter referred to as **CHARUSAT** which includes its heirs, assigners, executors, administrators etc.

**AND**

**Bhaikaka University** incorporated as Private University under the Gujarat Private University Act, 2009 having its registered office at the Bhaikaka University, Shree Krishna Hospital Campus, Gokal Nagar, Karamsad 388325, Dist: Anand, Gujarat representing through its Registrar, Bhaikaka University hereinafter referred to as **BU**.

**On mutual consent, the agreement has been extended for the next three years i.e. 01/04/2024 to 31/03/2027 for UG, PG & Ph.D. Programme.**

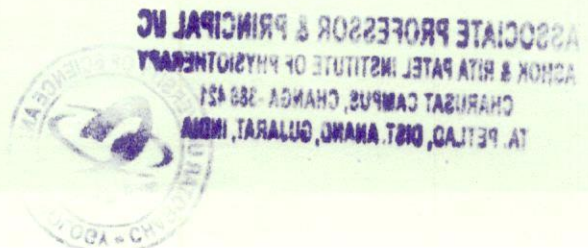
CHARUSAT runs professional education programmes in Engineering, Pharmacy, Computer Application, Business Management and Applied Science, CHARUSAT also offers healthcare education. It has started Bachelor of Physiotherapy (BPT) Programme from Academic Year 2009-10, Doctorate Programme (Ph.D) from 2011-12 and Master of Physiotherapy Programme from 2013-14. For the training of the students pursuing this programme, CHARUSAT intends to enter into an academic MoU with BU.

BU is managing institutions in the field of Health Professions Education and Research like Pramukhswami Medical College (PSMC), K M Patel Institute of Physiotherapy, G H Patel School of Nursing, Institute of Nursing Sciences, Smt. L P Patel Institute of Medical Laboratory Technology, CAM Institute of Allied Health Sciences & Technology and Amrita Patel Centre for Public Health along with Shree Krishna Hospital (SKH) as a teaching hospital along with Bhanubhai and Madhuben Patel Cardiac Centre, M S Patel Cancer Centre and Dinesh J Patel Bone Marrow Transplant Centre in the same campus.

The main purpose of the said MoU is to support each other in the area of Teaching and Research. Both parties agreed for having positive educational interactions for the benefit of students and faculty of both parties.

Now this Memorandum of Understanding is executed incorporating the following terms and conditions:

- i. BU agrees to have an academic MoU with CHARUSAT to the extent of educational support in the form of clinical exposure and training to the students, this will include access to the facilities like treatment procedures, methods, and keeping necessary for educating the students of BU during their regular studies and also during internship.
- ii. The students of CHARUSAT will strictly abide by the rules of BU and any kind of violation thereof will lead to denying the facilities available. Any damage caused by any student to the property or clinical facility will be compensated by CHARUSAT.
- iii. CHARUSAT shall not have any claim on physical facilities of BU or shall not claim any waiver of charges or any other such favors other than for the purpose of education from BU.







- iv. BU shall have an unequivocal right to bring an end to this agreement without assigning any reason or without any previous notice and CHARUSAT will not be entitled to any claim by way of compensation and/or damages.
- v. CHARUSAT shall not make any endeavors to have covetous gain from this agreement. It is specifically understood that this agreement entered by both the parties is only with the sole purpose of training students enrolled under different programmes of BU.
- vi. Students of CHARUSAT will not be allowed to deal with patients independently.
- vii. The Shree Krishna Hospital, a teaching hospital of BU, has qualified faculty in different disciplines. Their guidance shall be available to the students of CHARUSAT.
- viii. For Clinical training and internship at Shree Krishna Hospital, Karamsad, monthly fees to be paid by the CHARUSAT will be Rs. 5000/- (Five Thousand) per student and the fees will be reviewed and revised yearly as per the discretion of the authorities of Shree Krishna Hospital, Karamsad.
- ix. No other financial commitment or liability other than clause (viii) above from any party will be assumed unless a formal approval/acceptance to that effect has been accorded through signed documents by both the parties.
- x. This MoU may be terminated by either party with advance written notice of 30 days or by mutual understanding between the two parties.


This agreement shall remain in force for the next three years i.e. i.e. 01/04/2024 to 31/03/2027 for UG, PG & Ph.D. Programme. It can be further extended by mutual consent, if required, either in present form or with any modifications as the need by.
