MEMORANDUM OF UNDERSTANDING

The first Memorandum of Understanding (MoU) was executed from 01-01-2022 to 31-12-2023 at Karamsad between Charutar Vidya Mandal University, Vallabh Vidyanagar, Anand ; having its registered office at Vallabh Vidyanagar, Anand, through its Registrar hereinafter referred to as CVMU which includes its heirs, assigners, executors, administrators etc.

AND

Bhaikaka University incorporated as private university under the Gujarat Private Universities Act, 2009 having its registered office at the Bhaikaka University, Shree Krishna Hospital Campus, Gokal Nagar, Karamsad 388 325, Dist: Anand, Gujarat, representing through its Registrar, Bhaikaka University hereinafter referred to as BU.

On mutual consent, as on 01-01-2024, the agreement has been extended for next three years i.e., 01-01-2024 to 31-12-2027 for interns and knowledge exchange of UG, PG and PhD Programme students.

CVMU runs professional education programmes in Engineering & Technology, Commerce & Management, Pharmaceutical Sciences, Nursing, Education, Arts, Science, Architecture & Planning, Ayurvedic Medicine & Law.

BU is managing institutions in the field of Health Profession Education and Research like Pramukhswami Medical College (PSMC), H M Patel Institute of Post graduate studies, K M Patel Institute of Physiotherapy, G H Patel School of Nursing, Institute of Nursing Sciences, Smt. L P Patel Institute of Medical Laboratory Technology and CAM Institute of Allied Health Sciences & Technology along with Shree Krishna Hospital (SKH) as a teaching hospital along with Bhanubhai and Madhuben Patel Cardiac Centre, M S Patel Cancer Centre and Dinesh J Patel Bone Marrow Transplant Centre in the same campus.

The main purpose of the said MoU is to support each other in the area of Fieldwork Internship, Research & Development Services and related services. Both parties agree for having positive educational interactions for the benefit of students and faculty of both parties.

This Memorandum of Understanding has been executed incorporating the following terms and conditions:

- (i) Both the parties agree to have an academic MoU to the extent of educational support in the form of clinical exposure and training to the students.
- (ii) The students of both the parties will strictly abide by the rules of respective party and any kind of violation thereof will lead to denying the facilities available. Any damage caused by any student to the property or clinical facility will be compensated by concerned party.
- (iii) Both the parties shall not make any endeavours to have covetous gain from this agreement. It is specifically understood that this agreement entered by both the parties is only with the sole purpose of training of students of both the Universities, enrolled under different programmes/ courses.
- (iv) Seek finance of joint activities from sources available to them; however, the financial aspects of each activity will be addressed separately and an explicit documentation will be done for that purpose.
- (v) All intellectual property rights and their costs will be shared jointly through mutual discussions. All (raw) data resulting from joint research projects,

between the Parties which constitute the basis for joint publications must be available for storage in the repository of each Party.

- (vi) Students of CVMU will not be allowed to deal with patients independently at Shree Krishna Hospital.
- (vii) This MoU may be terminated by either party with advance written notice of 30 days or by mutual understanding between the two parties.
- (viii) Any differing viewpoints and interpretations of this MoU shall be settled by mutual consultation or negotiation.

This agreement shall remain in force for next three years i.e. **01-01-2024 to 31-12-2027** for interns of UG, PG & Ph. D. programmes. It can be further extended by mutual consent, if required, either in the present form or with any modifications as the need be.


